Whereas the Hon'ble Supreme Court of India in W.P(C) No. 406/2013 in Re-Human Conditions in 1932 Prisons directed to constitute the UNDER TRIAL REVIEW COMMITTEE with further direction to hold meeting quarterly. 
In the meeting, the Asstt Jailor, Sub Jail, Haflong has duly placed a list of UTPs before the committee for consideration. Following matters were taken up by the committee for consideration. The committee deliberated upon the lists and resolved as follows:

1. It is seen that at present there are 46 inmates lodged in sub-jail, Haflong. Out of these inmates, Shri Bitul Das(S/o- Shri Gobinda Das) is languishing in Jail since 20-10-2021 i/c/w GR case No.08/13 U/S-341/325/307 IPC and his case is pending before Hon'ble Court of Session , Dima Hasao.

2. Similarly Shri Turmiki Sunar (S/o-Shri Kamman Sunar) is languishing in Jail since 30-11-2021 i/c/w Umrangso PS case No.30/21 (GR case No.265/2021 U/S-379 IPC). The said accused is languishing in jail inspite of having been granted bail.
3. Shri Susen Parbosa (S/o-Shri Nandu Parbosa) is languishing in Jail since 12-01-2022 i/c/w Maibang PS case No.29/21 (GR case No. 185/2021 U/S-447/436/325/506/34 IPC). The said accused is languishing in jail inspite of having been granted bail.

Considering the length of detention already undergone by the above mentioned accused persons, the committee unanimously recommended release of the aforesaid three accused persons on Personal Recognizance (P.R) Bond.

The meeting ended with vote of thanks.
