The required number of outsourcing vehicle is one (01). The intending person/firm must submit their quotation in sealed envelope to the office of the undersigned on or before **16.06.2023** during the office hour. The tender may be dropped in the drop box installed in front of the main entrance of the Court Building at Jatinga or by post to O/o the Chief Judicial Magistrate, Dima Hasao, Haflong, Jatinga (Boro Haflong), Pin-788819, Assam.

Terms & Conditions:-

1. The maintenance and toll of the vehicle shall be done by the outsourcing vendor (except the salary of the Driver and fuel cost)
2. The vehicle should not be more than 3½ (Three and Half) years old from the date of registration. But if no such vehicle is found, criteria may be relaxed.
3. The contract period will be initially for one (01) year which may be extended (if necessary) or till new vehicle is provided by the Government.



4. In case of breach of any of the conditions (to be assigned in the agreement) by the vendor, the undersigned reserves the right to cancel the agreement before completion of the specified time period.
5. The interested parties (vendors) must submit the sealed quotation containing tender along with their GST Registration Certificate, PAN Card, Vehicle Registration Card, up to date Vehicle Insurance Certificate, recent Fitness Certificate of the vehicle issued by the MVI, District Transport Office etc.
6. The sealed envelope containing quotation shall be marked as “ **Quotation for Outsourcing Official Vehicles** ”.
7. Payment will be made through online mode after submission of the bills.
8. The undersigned reserves the right to accept or reject any or all the tenders, in part or in full without assigning any reason whatsoever.
