2. The sealed envelope of the firm submitting the quotation must be addressed to **THE CHIEF JUDICIAL MAGISTRATE, DIMA HASAO, HAFLONG, PIN: 788819**. The address of the firm must appear distinctly on the sealed envelope.
3. The bid documents are not transferable. The seal and signature of the authorized Official of the registered dealer must appear on all the papers of the bid documents.
4. The quotation should contain the following valid documents:-
  - i. Copy of GST Registration Certificate in the name of the registered dealers.
  - ii. Copy of Trade License issued by appropriate authority in the name of the registered supplier/firm/shop.
  - iii. Authorized dealership Certificate.
  - iv. Bank Account Details in the name of the registered supplier/firm/shop **(preferably SBI)**.
5. Rate should be quoted only against the items specified in the list.
6. The rate quoted for each item shall be final and no hike in price shall be considered during the contract period. Further, rate quoted in the price bid should be on door delivery to this establishment.
7. **The last date of submitting the tender is 17.06.2022 (up to 05.00 PM)**. Late and delayed tender will not be considered. In case any unscheduled holiday occurs on the prescribed closing date, the next working day shall be considered as the last date of submitting tender.
