 - i. Copy of the GST Registration Certificate in the name of the registered dealer.
 - ii. Copy of Trade License issued by appropriate authority in the name of the registered supplier/firm/shop.
 - iii. Authorized Dealership Certificate.
 - iv. Bank Account Details in the name of the registered supplier/firm/shop **(preferably SBI.)**
5. The rate should be quoted only against the items specified in the list.
6. The rate quoted for each item shall be final and no hike in price shall be considered during the contract period. Further, rate quoted in the price bid should be on door delivery to this establishment.
