The intending person/firm must submit their quotation in sealed envelope to the office of the undersigned on or before 23<sup>rd</sup> September, 2022 during the office hour. The tender may be dropped in the drop box installed in front of the main entrance of the Court Building at Jatinga.

**Terms & Conditions:-**

1. The maintenance and toll of the vehicle shall be done by the outsourcing vendor (except the salary of the Driver and fuel cost )
2. The vehicle should not be more than 03 (three) years old from the date of registration. But if no such vehicle is found, criteria may be relaxed.
3. The contract period will be initially for 01 (one) year which may be extended (if necessary) or till new vehicle is provided by the Government.
4. In case of breach of any of the conditions (to be assigned in the agreement) by the vendor, the undersigned reserves the right to cancel the agreement before completion of the specified time period.
5. The interested parties (vendors) must submit the sealed quotation containing tender along with their GST Registration Certificate, PAN Card, Vehicle



Registration Card, up to date Vehicle Insurance Certificate, recent Fitness Certificate of the vehicle issued by the MVI, District Transport Office etc.

6. The sealed envelope containing quotation shall be marked as "**Quotation for Outsourcing Vehicles for the Establishment of Chief Judicial Magistrate, Dima Hasao**".
7. Payment shall be made through online mode after submission of the bills.
